The trustees shall not be personally liable for such guarantee or the security otherwise than for willful negligence.

- (g) To open accounts whether current, fixed safe-custody overdraft and savings or of any other types of account in the name of the Trust with any bank or banks, post office or other institutions of any nature and to operate the same jointly or severally or otherwise or by appointing any authorized signatory or agent as Trustees at their discretion think fit and proper.
